I. Call to Order

III. Consent Agenda

Motion by Mace, seconded by Kingsbury, to approve the previous meeting minutes, vouchers, and receipts. Motion carried.

IV. Previous/Ongoing Business

a) Snowplowing Agreement-Owen presented the agreement and shared that the county commissioners and hospital CEO have signed the agreement. Motion by Wick, seconded by Peterson, to approve and sign the agreement as presented. Motion carried.

V. New Business

- a) Resolution 2023-1 GAAP-Motion by Peterson, seconded by Kingsbury, to adopt Resolution 2023. Motion carried.
- b) Resolution 2023-2 Newspaper Designation-Motion by Wick, seconded by Mace, to adopt Resolution 2023-2 designating the Smith County Pioneer as the official newspaper for legal publications. Motion carried.

- e) Advance Insurance-Conaway presented the renewal information, with a premium increase of \$0.01 per employee. Motion by Peterson, seconded by Wick, to approve the renewal of Advance Insurance effective March 1. Motion carried.

VI. Department Reports/Committee & Board Report

a) Police Department-Chief Jamie Marshall updated the council on applications and an issue with the 2013 Dodge that Hileman was able to repair.

b) Conaway-Reported on an email received on the pre-application for replacement of the water transmission lines, reporting that the city ranked third in the emerging contaminants category, which should put the city in a good spot for funding.

- b) Wick-Pool/Recreation Commission/Transit
