

## **ORDINANCE NO. 1021**

### **Designates Emergency Routes and Requires Parallel Parking On Certain City Streets Repeals Ordinance No. 946**

An ordinance repealing ordinance no. 946 defining the designated streets where the parking of motor vehicles in the City of Smith Center, Kansas, is prohibited or parallel parking required during blizzard or emergency conditions.

Be it ordained by the governing body of the City of Smith Center, Kansas:

Section 1. Ordinance no. 946 is repealed from and after the effective date of this ordinance.

Section 2. No owner or operator of any motor vehicle shall allow said vehicle to be parked in any manner on the following described streets in the City of Smith Center, Kansas:

Main Street south from US- 36 to the South City Limits of the city;  
Court Street from Armory Road east to the city limits;  
Kansas Avenue from Main Street east to the city limits;  
Second Street from Monroe Street east to Roger Barta Way;  
Roger Barta Way from Second Street north to US-36;  
Third Street from White Rock Road east to Roger Barta Way;  
Womer from Court Street north to Kansas Avenue;  
Park Street from Kansas Avenue north to Second Street;  
Belmont Street from Court Street north to Kansas Avenue;  
A Street from 3<sup>rd</sup> Street north to US-36;  
New York Street from Main Street east to Jefferson Street; and  
Jefferson Street from New York Street north to Court Street.

during snow storms or other emergency conditions, following declaration of such emergency and announcement thereof by the Mayor of Smith Center, Kansas.

**Furthermore**, when snowfall shall exceed two (2) inches, and without the necessity of declaration of an emergency, parallel parking shall be required on the following streets:

Main Street from the railroad right-of-way north to First Street;  
Kansas Avenue from Washington Street east to Madison Avenue;  
Court Street from Washington Street east to Madison Avenue;  
New York Street from Main Street east to Madison Street.

Section 3. The owner or operator of said vehicle shall be contacted by City Personnel and shall be requested to move said vehicle, and if the owner or operator fails to remove said parked vehicle from the street, the owner or operator shall be in violation of this ordinance and shall be punished as provided. In the event that the owner or operator of said parked vehicle cannot be located or if the owner or operator of said vehicle refuses to move the vehicle, the vehicle shall be towed off of said street at the expense of the owner or operator, and the owner or operator shall be deemed in violation of this ordinance.

Section 4. Penalties. Any person violating this ordinance, upon having been found guilty, shall pay a fine of not more than \$100.00.

Section 5. This ordinance shall be in full force and effect from and after its publication in the Smith County Pioneer.
